Consistent with its duty to provide and maintain a learning and training environment that is free of recognized hazards, the purpose of this policy is to minimize exposure to and transmission of the COVID-19 virus by providing protection to participants and thereby preventing exposure to participants. The FDA issued emergency use authorization for COVID-19 vaccinations. The approved vaccinations have been found to be effective in reducing the risk of contracting the virus and related transmission. The Centers for Disease Control and Prevention (CDC) and Indiana Department of Public Health (IDPH) recommend vaccination of persons to reduce the risk of spread of the virus to communities

## II. General Requirements

The Emergence program is a highly interactive and engaging training opportunity that requires physical contact with others over the course of eight (8) weeks. Due to the close quarters needed, we are requiring all participants that are involved to be fully vaccinated for COVID-19 before the program start date. This is a safety precaution so that we can guarantee a quality experience for those that wish to participate in this program.

Participants who decline to get fully COVID-19 vaccinated will not be allowed to take part in the Emergence program.
